Explanations

Any fees charged by the operator only apply when using the respective highway network. In principle, you must specify in advance whether and which discounts from the French highway companies you wish to use.

Automatic toll collection is not yet possible at the Mont Blanc Tunnel and the Tunnel du Fréjus.

The operating companies CEVM and ADELAC do not grant any discounts.

The French highway operators do not grant any discounts for the use of parking spaces.

(1) **APRR**: From 01.02.2024, discounts will again be granted at the "Maurice Lemaire - Lusse toll station (APRR)" tunnel.

(2) **AREA**: When using the AREA discount program, a monthly fee of € 1.80 (excl. VAT) is automatically charged, starting with the first transaction made.

(3) **ALIAE**: The additional discount per OBU for the Euro pollutant class is only granted at the traditional toll station for the route "Limite de concession A71/A79 -Barrière de Deux-Chaises". On the free-flow route, the Euro pollutant class is directly included in the tariff.

(4) **ARCOUR**: The discounts are only granted when entering via an ARCOUR toll station and exiting via an ARCOUR toll station. No discounts are granted when entering and/or exiting via a toll station of another highway operator.

(5) **COFIROUTE**: The detour routes at Tours are not taken into account for the calculation of discounts.

(6) **ALICORNE**: Only for the Sées-N°16 entry or exit station

(7) **ATLANDES**: A discount of 9.65% for trucks (class C) and 9.80% for trucks (class A and B) is granted if the box "Motorization type" (P.3 indication on the vehicle registration document) is personalized with the indications 14 (GNC) and 15 (GNL).

(8) **ALIS**: Only for the routes: Gacé-Orbecand Gacé-Bernay

In accordance with the Eurovignette Directive, the maximum cumulative discount granted per highway company is 13% of the total net toll consumption per DKV BOX.

If the toll payment with the DKV BOX was not carried out in fully automatic mode but by manual entry, no discount is granted. If the license plate number of the vehicle does not match the license plate number stored in the DKV BOX, no discount will be granted.

The repeated detection of a difference will be considered by the operator as an attempt at fraud and will lead to exclusion from the discount program without prior notice. The operators reserve the right to take further legal action.
